Our solution provides an easy means of maintaining the SOP as required by the Authorities. It helps keep the company staff's and visitor's health screening record and stored as required by authority.

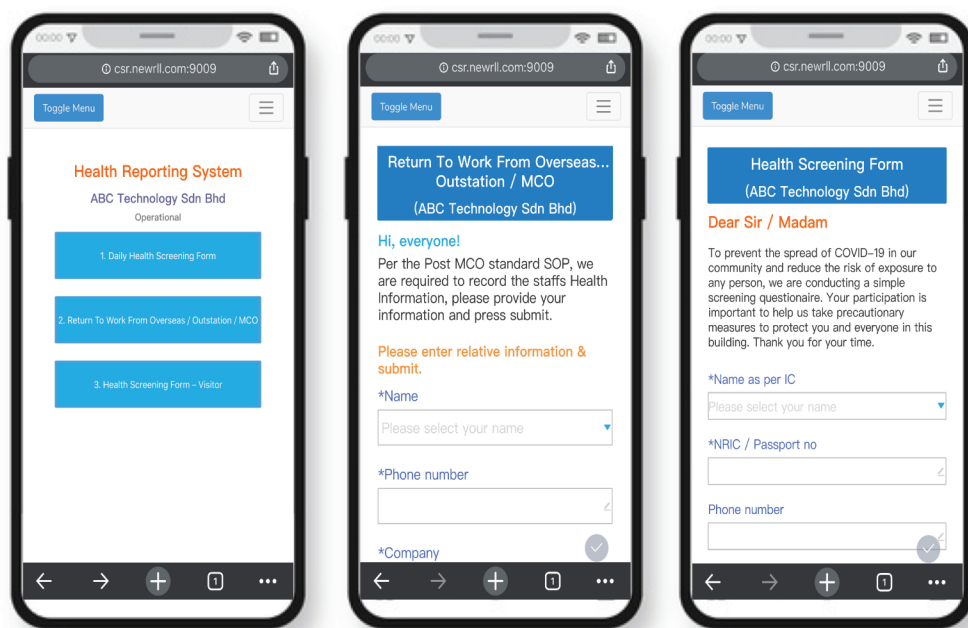
